

RELEASE FORM OF THE HIGH ROPES COURSE

Please read following instructions carefully:

The High Ropes Course in Gänsehäufelbad is designed with the **intent to challenge** participants physically, psychologically and mentally. The station varies in height from 0' to 8' meters above ground.

Participants of the course will navigate independently from station to station without a guide and are expected to be completely responsible for themselves. The high ropes course is **TÜV-certified in Austria**, approved by the **ERCA (European Ropes Course Association)** and certified with the **SAFETY-LINE®** safety system, representing the highest safety status "E" from EN 15567 (it is not possible to unhook the carabiners completely). It is important that all participants take full responsibility and understand the risks involved in taking part in the challenges presented at the high ropes course.

DISCLAIMER

I am completely aware that the high ropes course will place high **physical and psychological demands** on the participant. In addition, the participant acknowledges that in taking part in the activities of the high ropes course, there is a possibility of severe injury. I fully understand the risk involved in the high ropes course and I (and/or my kid/kids) enter at my/their **own risk voluntarily**. I assume all dangers or risks (both known and unknown) associated with my participation in the high ropes course and release Event4you GmbH as well as their staff from all legal claims arising from my participation. According to my own estimations (on site or from pictures on the internet) regarding the high ropes course, I consider myself and/or my children fully capable of managing the course independently. After a preliminary introduction regarding the use of the course and in accordance with the safety regulations, you/ or your children as participants, have the option to discontinue the course and receive a full refund.

I confirm that I have completed the registration form truthfully and that me or my children do not have any health-related problems or handicaps that could impair my activities in the high ropes course.

I commit myself to inform the Event4you GmbH management immediately if any circumstances such as injuries or illness arise that could impair my or the ability of my children to continue with my participation in the high ropes course.
